OCCUPATIONAL BACKGROUND: I have worked as an attorney in private practice since my graduation from law school in 1984. I have been active in the Debtor-Creditor Section of the Oregon State Bar, having served on the Section's executive committee, and also as a past chairman of the Section's continuing legal education subcommittee. For a number of years, I served as a volunteer lawyer for the St. Andrew Legal Clinic, and in 1999, I was named as "Boss of the Year" by the Portland Legal Secretaries Association.

EDUCATIONAL BACKGROUND: University of Oregon Law School, J.D., 1984.

Harvard University, B.A. cum laude in History, 1980.

With respect to short-term goals, I support the City's new library and city park expansion, as well as the revitalization of the Fifth Street corridor. On a long-term basis, I support City-School partnerships, such as the library's homework center and the arts commission's student programs.

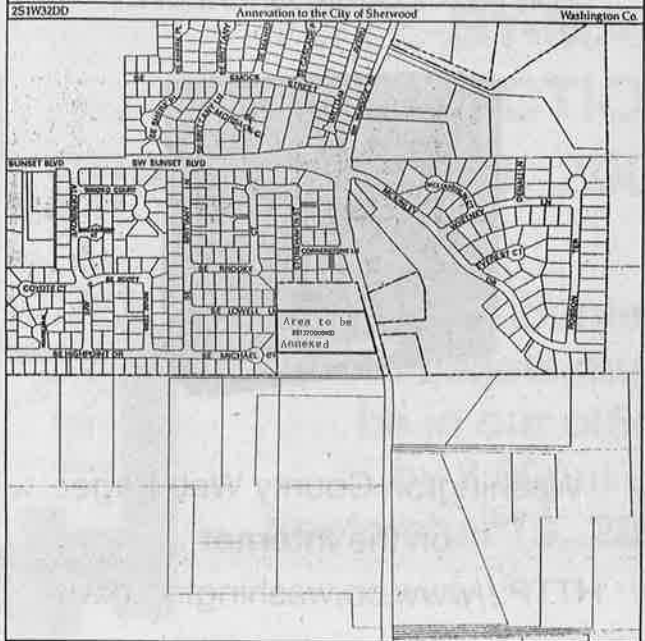
PROPOSAL TO ANNEX TO CITY 3.15 ACRE PARCEL

QUESTION: Shall Tax Lot 400, Assessor's Map No. 2S132DD, be included within the City of Sherwood Corporate Boundary?

SUMMARY: Approval of this ballot measure would allow annexation of a 3.15 acre parcel of land to within the corporate boundaries of the City of Sherwood. This parcel is known as tax lot 400, Assessor's Map No. 2S132DD. A legal description for the parcel and maps of the parcel are on file at the Sherwood City Hall, as well as the application staff report, and findings for public inspection.
