

# **ENHANCED SHERIFF'S PATROL DISTRICT (ESPD)**

# **SERVING OREGON'S SAFEST MAJOR URBAN COUNTY**

Maintaining Washington County as the safest urban County in Oregon requires a thoughtful approach and responsive service. Initially formed in 1987, the Enhanced Sheriff's Patrol District (ESPD) is a special service district created to respond to the specific safety needs in the urban unincorporated areas of the County. With a denser population and more businesses and schools, this service district requires adequate staffing levels to meet the needs of our growing community.

To best serve our communities, each service area in the County is assigned a Sergeant directly responsible for problem-solving and strategic planning. **Together, deputies and the beat sergeant understand area residents' needs and tailor service locally for community engagement and accountability.** Beat sergeants and deputies regularly connect and collaborate with the community — through events, schools, community groups, local business associations or community meetings, and educational public safety presentations. Lieutenants are responsible for sectors or a collection of beats in similar geographic areas. Taking a broader holistic look, the lieutenants assess the community's collective needs, identify problems, and help leverage available assistance.

## **ESPD OVERVIEW**

Provides around one (1.08) deputy per 1,000 residents

Delivers urban level public safety services to residents in the urban unincorporated areas

Continuous voter approval for the past 33 years, 76% of voters approved levy renewal through 2023



### **SERVICE LEVEL AND RESPONSE**

The ESPD is a service district formed by the Board of County Commissioners (BCC) and approved by voters in 1987. Its purpose is to provide residents of urban unincorporated Washington County a mechanism to increase public safety service levels beyond the traditionally provided County base-level of about .50 officers-per-1,000 residents to a level of about 1.00 officers-per-1,000 residents. Maintaining this staffing level is essential for WCSO to provide immediate 9-1-1 response and follow-up investigations.
