## ADDITIONAL SERVICES AND FEES

Rates effective July 1, 2011

### Additional Yard Debris Services and Fees

*Includes every-other-week collection of yard debris using hauler provided 60-gallon carts.*

*\*Applies to Urban customer only. Rural customers do not receive yard debris collection services.*

<b>Yard Debris-Only Service:</b> Available to all urban customers who <u>do not</u> already subscribe to <i>Standard Residential Collection Service</i> .	\$4.45/month
<b>Additional Yard Debris Cart:</b> Available to <i>Standard Residential</i> and <i>Yard Debris-Only</i> customers.	\$3.58/month
<b>Extra Can/Bag/Bundle of Yard Debris:</b> Available to <i>Standard Residential</i> and <i>Yard Debris-Only</i> customers.	\$2.86 each

<b>Extra Bag/Bundle of Garbage</b>	\$5.96	\$6.35
<b>Call Backs:</b> Charged when pickup is missed due to customers error. <i>Administrative Rules Section 14(E)b4.</i>	\$13.50	\$14.07
<b>Drop Box/Compactor Service Interference Fee:</b> Charged when driver is unable to safely service a compactor/drop box because of site issues such as blocked access to compactor/drop box.	\$35.00	\$70.00
<b>Drop Box Relocation Fee:</b> Charged when customer requests collection company make a special trip to site to relocate a drop box on the same site.	\$35.00	\$70.00
<b>Over-Capacity Charge:</b> Fee charged to can/cart customers when garbage container is overfilled. A good indicator of over-filling is that the lid does not close.	\$2.75	
<b>NSF Charge:</b> Charged for non-sufficient funds.	\$30.00	
<b>Reinstatement Fee:</b> Charged after cancellation for non-payment.	\$25.00	
<b>Unscheduled Service:</b> Charged for out-of-the-ordinary service collection of bulky items such as tires or appliances, as well as for requests for other unscheduled services.	\$75.00 per hour plus disposal, if applicable	
<b>Unreturned Cart Fee:</b> Applies to residential service only. <i>See Administrative Rule 14(F)f.</i>	\$50.00	
<b>Locked Containers/Doors Fee:</b> Applicable if a commercial customer utilizes locks on the container or enclosure gate that requires that the collection company driver to unlock container or gate.	\$10.00 per month/per lock	
<b>Distance Charge:</b> Fee charged to residential can/cart customers when garbage can/cart is placed more than 5 feet from curb/roadside. The per-foot charge is applied after the first 50 feet to a maximum Distance Charge of \$20.00. <i>See Administrative Rules Section 14M(a)5 and 14M(b)3.</i>	\$3.22 + 5 cents per foot	
<b>Commercial Compactor Turn-Around Fee:</b> Charged per occurrence when collection requires driver to turn around the compactor.	\$35.00	

\*Urban customers are located within the Metropolitan Service District Boundary.

Rural customers are located outside the Metropolitan Service District Boundary.
