

## **WHY WE NEED PUBLIC LAW LIBRARIES**

### **SAMPLE PUBLIC LAW LIBRARY REFERENCE QUESTIONS**

- Public law librarians show people how to research legal questions and to develop problem-solving strategies.
- Public law librarians do not solve their patrons' legal problems.
- Public law librarians always recommend that the law library patron consult an attorney.
- Public law librarians refer people to online and community-based legal information and legal service resources.
- Would YOU use *Google™* to find "*the answer*" to a personal and serious legal problem?

*What would these people do if they didn't have a public law library where they get expert help researching the law or finding referrals to qualified attorneys and legal aid services?*

Q: My veteran's benefits were denied. How do I appeal that?

Q: I am trying to determine if there were any zoning/ subdivision codes or laws for the State of Oregon in May 1970.

Q: If I were to get married and then decide I didn't want to be, what are the options to legally end the marriage? Obviously divorce is an option. How much would that cost and what does it entail?

Q: I am looking for any laws governing informed consent and also critical access hospitals in Oregon. I have not been able to find anything on the website.

Q: How do I get my ex out of my house? The judge in my divorce gave me the house.

Q: I have a rental property in Oregon. I haven't raised the rent in 3 years, and now wish to do so. Is there a maximum amount, or percentage of the current rent, that the rent can be legally raised?

Q: What is the statute of limitations on a debt? I'm being sued for a debt I thought I paid several years ago.

Q: What is the definition of "assault?"

Q: I want to get divorced and I can't afford an attorney.

Q: How do I make payment for restitution?

Q: How do I file a complaint against an attorney?

Q: Can I carry a butterfly knife in Oregon?

Q: Can I post pictures of my nephews on my web page, without the permission of their parents?

Q: How can I evict my tenant?

Q: How do I file a lawsuit?

Q: How can I get custody of my grandchildren?

Q: I want to start a business in .... city.

Q: Can my condo association require me to let a sprinkler inspector into my unit?

Q: I have a question about copyright law. If I'm publishing a book and want to use a page out of a dictionary in the book, does the dictionary need to be out of copyright and if so, how old does the dictionary need to be?

Q: I am looking for a template for a 30 day eviction notice. This is for a family member that does not pay rent.

Q: I need to find out how to file a lien against the owners of horses in my boarding stable that owe me money

Q: I need to know about the Oregon law that states you must let your dishes drip dry.

Q: Where do I file a claim for the class action suit for the enron settlement case?

Q: Does Oregon have a RoHS law (restriction of Hazardous Substances)? This is a law passed in Europe but in the US.

Q: What is the statute of limitations for small claims court? If I wanted to take someone to court for a small claims matter, what is the statute of limitations? Also, what is the procedure for collecting monies.

Q: I am looking for Oregon law on mobile advertisements.

Q: I am looking for some information or resources on a medical suspension on drivers' license and have been driving sometimes and have gotten caught doing so.

Q: What are the legal ramifications regarding the executor of my deceased father's estate (out of state patron)?

Q: Are ferrets legal in Oregon?

Q: How do I file a complaint I have against a local business.

Q: My daughter sent us a power of attorney and she is in xxx correctional facility, and i need to know, does it need to be recorded? I have never done this before, and someone mentioned this to me. Last year her dad had it, and i don't even know if he recorded it ... in 3 counties; is there a fee?

Q: Is it legal for a business to pay an individual's personal car insurance policy fees if they use the car for work and personal use?

Q: I've checked the OSBN site for info on role of the RN in a code situation--can an RN run a code w/o an MD if one doesn't respond (ie order meds given and which meds)?

Q: There is a discussion here at our Condos about changing the bi-laws and making it mandatory that owners live in their units and not be able to rent them out. By any chance would that policy be against the law? Can you direct me to the answer?

Q: How do I access free public records of xxx County, Oregon Court Records & Conviction Information? (family law case, ex in prison, current spouse wants to adopt)

Q: Trying to find the laws regarding an 18 year old dating a 16 year old.

Q: Where can I find free or cheap dental clinics?

Q: How do I find out the history of a Regulation (OAR or CFR)?

Q: Looking for a date of a divorce and other court records from several years ago.

Q: What does the abbreviation *Wall* refer to?

Q: If I co-signed for a car, and the car was repoed, if the person I co signed for filed Chapter 13 will the repo be removed from my credit?

Q: If some one gives a resign[ation] letter to a company, then decides to pull it back, (not to resign) can they pull it back or it gets too late?

Q: What are the Oregon laws on homesteading?

Q: Where do I dispose of used needles?

Q: how can I look up the laws dealing with child custody if parents are not married and if the parent wishes to come home to raise her daughter and have the support and help needed to do so?

Q: Should I file for bankruptcy?

Q: I live in a manufactured home and [defect, eviction, etc.]

Q: How do I defend myself against a stalking order?

Q: How can I compile a mailing database for my new business?

Q: We manage a property in xxx and need some help with what is required on a Notice of Non-Responsibility. In California we post then we record with the County Recorder. Do we do the same and if so what is the cost and to whom do we send it?

Q: Is there a new state law that defines subcontractors in regard to whether one should be employed as an employee or a subcontractor? If so what is the new law?

Q: Where can I find info on what land MUST be taken into a 50 year Urban Reserve Area. i.e.,: any land within ½ mile of the new city line, etc.

Q: How do I find out if a law is being broken when a organization advertises a movie in a recreation center for viewing. Does this violate copyright?

Q: I am looking for the Oregon Statute number for the Uniform Accident and Sickness Policy Provision Law.

Q: I'm trying to find a month-to-month rental agreement from online.

Q: Was the [California] statute wording the same in 1988 as it is now?

Q: there is a federal law that I am looking for that states that power companies cannot turn power off if you have children or the elderly. Where do I find this law?

Q: Where can I get a copy of actual traffic laws? The citation I am looking for is ORS xxx.xxx.

Q: I'd like to file an FOI with the State Dept. for information on the Yalta minutes.

Q: We are looking for the English translations of the following legal phrases in Spanish ...

Q: What is the minimum age for children to be at home on their own for 2-3 hours?

Q: I use swords for my martial arts class. How do I legally transport, store, or carry them? If I collect them do I have to keep them locked up in any special way in my car or at home?

Q: I am comparing and contrasting on state politics vs. other state on taxes.

Q: Would a tournament based on skill (eg.skateboarding, paint balling, basketball, etc.) be considered gambling if the contestants and teams of contestants were to "buy-in" for an entry fee, where a small percentage is taken by the host of the tournament and the remaining amount of money is used to be distributed between the ranking of the contestants, based on the outcome of the tournament?

Q: Can my landlord enter my backyard without the 24 hour notice he is required to give to enter my apartment?

Q: The xxx school district has a new policy on behavior. How can I get a copy of it?
