Getting Started

If you believe that you or your family member is a candidate for orthodontic treatment, then the first step is to schedule an examination and consultation. You do not need a referral from a primary care dentist to make this appointment, simply call us at 877-777-1012 and ask for a **pre-orthodontia consultation** at a Willamette Dental Office near you.

This consultation consists of three separate meetings with a Willamette Dental orthodontist. At the first appointment your orthodontist performs a initial examination of your bite and answers any questions that you may have. At the next appointment, we take x-rays and photographs, as well as make models of your teeth. The results of these examinations are studied and a plan of your treatment is developed. At the third meeting, your orthodontist will present to you our recommendation of the best treatment to re-align your teeth. Also, you will receive a comprehensive written estimate of your treatment including its cost and a time-line of procedures.

When you wish to commence treatment, your Willamette Dental office manager will coordinate your financial arrangements with us. Typically, a major portion of the treatment fee is required at your first banding appointment, and then the balance of the fee can be paid in monthly installments over the following twelve months.
