


Supportive Housing Services Program

- passed in 2020 by voters in the Metro region
- Scale homeless services from \$4M to ≈ \$70M
- Regional measure in collaboration with Clackamas and Multnomah County
- Scaled to achieve functional zero for people experiencing chronic homelessness



Homeless and Housing Services Funding





Housing Case Management Program

- 20 partnering service providers
- 20 participants per case manager
- 1370 household slots

Regional Long-term Rent Assistance



- Medium-term housing assistance: 3-24 months
- 19 organizations and up to 26 new case managers
- Target: 520 households
- Rental assistance


Permanent Supportive Housing

Heartwood Commons


- Resident services, culturally specific housing services, and community behavioral health services on site

Supportive Housing Capacity








Access Programs

Year 2 expansion:

- 40 bridge shelter beds (Tigard)
- 30 village pods (Hillsboro)
- 150 winter shelter beds (dispersed)
- New Outreach Worker system
- \$10 million shelter capital fund

- 5 liaison positions embedded in five Health and Human Services Department Programs.
- Goal: Leverage existing systems of care while addressing the housing needs of vulnerable communities. Provide housing system expertise for health service providers.
 - Hawthorn Walk-in Center
 - Maternal, Child and Family Program
 - Behavioral Health Intensive Care Coordination
 - Developmental Disabilities Division
 - Disability, Aging and Veteran Services Program





- Medical services at shelter site in partnership with Virginia Garcia Memorial Health Center.
- Goal: Provide shelter and stabilizing medical support for houseless individuals discharging from in-patient medical settings.
- 10 initial beds at the Hillsboro Bridge Shelter site
- Launch summer 2023



Healthcare and Homeless Initiative

- Convened by Community Solutions and Institute for Healthcare Improvement.
- Partnership with Kaiser Permanente and Providence Health System to explore meaningful contributions healthcare can make toward ending chronic homelessness.
 - HealthShare and CareOregon are tentative partners.
- Washington County is one of five pilot sites nationally.

Healthcare Case Conferencing

- Goal: Connect participants to necessary health services, reduce barriers to care, and address health and housing barriers to stability in tandem.
- Long-term collaboration that builds on the care coordination work of a winter shelter pilot.
- Bi-weekly case conferencing focused on a by-name list of those experiencing homelessness with a disabling condition and identified care needs.
- Broad buy-in from housing providers and health systems.



System Navigation and Training

Behavioral Health Training Series

- Goal: Equip direct service providers with necessary skills to better engage and serve houseless people with complex needs and connect them to appropriate care.
 - Navigating the behavioral health system
 - Conflict resolution and de-escalation
 - Question Persuade, Refer suicide prevention
 - Harm Reduction 101
 - Understanding substance use and tools for engagement
 - Navigating Oregon Health Plan





Medicaid 1115 Waiver

- Targeted demonstration program leveraging Health-Related Social Needs Services for households in transition
- 6 months of rental assistance, housing, navigation, and case management support
- July 2024

• Ongoing regional coordination with HealthShare, Multnomah County, Clackamas County, and Metro
