
### PRESENTATIONS

#### UPDATES ON SUBSTANCE PREVENTION ACROSS HHS, presented by Gwyn Ashcom, Prevention Team Supervisor

PHAC members received an update on substance prevention work across Health and Human Services, including strategic visioning, collaborative activities, and youth engagement planning. (Please refer to slide presentation entitled, "PHAC – HHS Prevention 10-10-23" for detailed information.)

- HHS is hosting prevention retreats with community partners and taking a collaborative approach to prevention. The goal is to understand the underlying factors that influence substance use as well as protective factors.
- > Areas of interest chosen by youth: youth are expressing interest in mental health.
- The group discussed expanding social-emotional learning in k-12 to help further prevention and including cannabis in prevention efforts.
