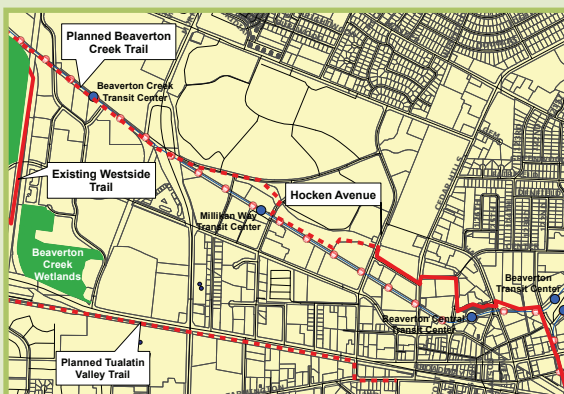

Metro Approves Grant for THPRD Trail Segment

Metro Council has approved a \$3.7 million federal grant to the Tualatin Hills Park & Recreation District for construction of a new, 1.5-mile trail that will offer a variety of benefits to users. The Beaverton Creek Trail will run east-west and connect Hocken Avenue to the Westside Regional Trail at the Tualatin Hills Nature Park. It will fill a gap in THPRD's 70-mile trail system for walkers, joggers, bicyclists and others. Funding will be awarded in 2019. The park district anticipates starting construction in 2020 and finishing by the end of 2021. More information at: <http://bit.ly/2nan0fi>
