Will-Call Service (Less than weekly garbage collection)

Will-Call customers receive: one 32-gallon cart** for garbage collection on a per-call basis, up to two 96-gallon carts for regular every-other-week recycling collection and one red bin for regular every-other-week glass collection. Urban customers* also receive one 60-gallon cart for regular every-other-week yard debris collection.

Will-Call is composed of two fees (Service Fee + Collection Fee).

Residential Recycling-Only Service

Recycling-Only customers receive:

- one 96-gallon cart for every-other-week recycling collection
- one red bin for every-other-week glass collection

**Containers and Receptacles: The hauler shall be responsible for furnishing, delivering, maintaining, and replacing all solid waste, yard debris and recycling receptacles. However, rural customers may choose to provide the can for 32-gallon or smaller service.

Vacation Credit: No more than two billing credits will be given to customers who stop service for a period of two consecutive weeks or longer within a single calendar year period. See Administrative Rules Section 14(1)(c) for further details.

Commercial Container and Can/Cart garbage service INCLUDES unlimited recycling collection. Recycling receptacles shall be provided by the hauler at no additional charge.

Saturday collection service: Customers with service frequency of less than six times per week will be charged an additional 6% above the appropriate times per week collection rate if they include Saturday collection service. For example: An account that has Monday, Wednesday, and Saturday service will be charged an additional 6% on the appropriate 3 times per week collection rate.

Collection of compacted material: Containers with compacted materials are charged 2.25 times the loose rate. These rates are based on containers from 1 to 4 yards in size.

Rural* Customer Surcharge: \$2.00 surcharge per customer, per stop. Applies to first container only.

Commercial Food Scraps Collection Service is only available to urban* customers.

Collection Frequency: Cart commercial food scraps collection service shall be provided, as requested by the customer, at either 1 or 2 pick-ups per week. Additional pick-ups may be provided at the discretion of the service provider; however, service providers are not required to offer more than 2 pick-ups per week.

Additional collection pick-up frequency, if available, will be charged at the cart monthly rate.

COMPACTOR, DROP BOX AND OCCASIONAL CONTAINERS Rates effective July 1, 2017

Compactor and Drop Box Services

Compactors: For customers with compactor service supplying their own compactors.		
10-29 cubic yards	\$178.00	
30 cubic yards and greater	\$201.00	
Drop Box: For customers needing one-time or recurring usage of drop box.		
10-19 and 20 yard	\$133.00	
30 yard	\$150.00	
40 yard	\$158.00	
Saturday service: Charged at 1.5 times the regular haul rate (above) and shall be arranged with the collection company prior to service.		
*Additional Fees and Charges:		
Disposal: The actual charge to the hauler at the disposal site usually charged per ton of material. This fee is then charged to the customer.		
Fees/Profit Margin: The County fee and the certificate holder profit margin applied to the cost of disposal only.		
Drop Box Delivery/Set Up Fee: A \$20 fee assessed on all non-recurring (non-exchange) drop box customers, and to recurring customers for first-time delivery of a drop box. The delivery fee does not apply to compactor or occasional container service.		
Mileage: Charged at \$2.69 per mile from pick-up of the box/compactor container material to the nearest authorized disposal site by public highway.		
Demurrage: The daily rental fee after two calendar days (not including Sunday). See <i>Administrative Rules Section 14(S)(d)(4)</i> .

Mileage: Charged at \$2.69 per mile from pick-up of the box container material to the nearest authorized disposal site by public highway.	
Demurrage: The daily rental fee after two calendar days (not including Sunday) is \$3.23 per day.	
Overweight Containers: For penalties assessed on overweight containers. See <i>Administrative Rules Sections 14(O)(c) and 14(P)(b)</i> .

Additional Yard Debris Services and Fees

Includes every-other-week collection of yard debris using hauler provided 60-gallon carts.

**Applies to Urban customers only. Rural customers do not receive yard debris collection services.*

Yard Debris-Only Service: Available to all urban customers who <u>do not</u> already subscribe to <i>Standard Residential Collection Service</i> .	\$4.66/month
Additional Yard Debris Cart: Available to <i>Standard Residential</i> and <i>Yard Debris-Only</i> customers.	\$1.50/month
Extra Can/Bag/Bundle of Yard Debris: Available to <i>Standard Residential</i> and <i>Yard Debris-Only</i> customers.	\$3.00 each

Call Backs: Charged when pickup is missed due to customer error. <i>See Administrative Rules Section 14(E)(b)(4).</i>	\$14.17	\$14.76
Distance Charge: Monthly fee charged to residential can/cart customers when receptacles are placed more than 5 feet from the curbside or the roadside. Haulers shall provide non-curbside or non-roadside residential collection service at no extra charge to disabled residential customers. <i>See Administrative Rules Sections 14N(b)(6) and 14N(c)(5).</i>	5 feet to 150 feet	\$13.00
	151 feet or greater	\$20.00
Drop Box/Compactor Service Interference Fee: Charged when the driver is unable to safely service a compactor/drop box because of site issues such as blocked access to the compactor/drop box.	\$35.00	\$70.00
Drop Box Relocation Fee: Charged when the customer requests that the collection company make a special trip to the site to relocate a drop box on the same site.	\$35.00	\$70.00
Commercial Compactor Turn-Around Fee: Charged per occurrence when collection requires the driver to turn around the compactor.	\$35.00	
Locked Containers/Doors Fee: Applicable if a commercial customer utilizes locks on the container or enclosure gate that requires that the collection company driver unlock the container or gate.	\$10.00 per month/per lock	
Over-Capacity Charge: Fee charged to can/cart customers when the garbage container is overfilled. A good indicator of over-filling is that the lid does not close.	\$2.75	
Unreturned Cart Fee: Applies to residential service only. <i>See Administrative Rules Section 14(F)(g).</i>	\$50.00	
NSF Charge: Charged for non-sufficient funds.	\$30.00	
Reinstatement Fee: Charged after cancellation for non-payment.	\$25.00	
Unscheduled Service: Charged for out-of-the-ordinary service collection of bulky items such as tires or appliances, as well as for requests for other unscheduled services.	\$75.00 per hour plus disposal, if applicable
