The Garrett Lee Smith Safe Haven program serves chronically homeless individuals with severe and persistent mental illness. Utilizing a low-barrier, Housing First model, the Safe Haven serves those who have, in the past, been unable or unwilling to participate in traditional mental health treatment programs. This model encourages individuals with serious mental illness - some of whom with co-occurring substance abuse disorders - to voluntarily obtain permanent housing and access to on-site support services. Since opening in March 2007, Safe Haven has continued to achieve successful outcomes in housing stability, maintaining or increasing income, and increasing independent living skills.

The 10-bed facility is located in downtown Hillsboro in a renovated, historic building. Supports are tailored to the unique needs of this population, including 24/7 staffing with Supported Housing Specialists, an on-site Qualified Mental Health Professional (QMHP), and services and provisions to assist with meeting basic needs. Engagement in the complete continuum of available services is voluntary and housing is not contingent on participation. On-site services and supports include client-centered treatment planning, life skills training, housing placement, counseling and crisis services, employment services, connection to social supports, and assistance obtaining benefits and entitlements. Additional supports such as annual integrated assessments, psychiatric intakes, medication management, and groups are also available on-site or at a Luke-Dorf clinic depending on individual need.

Outreach and referral to the program are conducted in alignment with Community Connect, the CoC coordinated entry system, with a mobile assessment team serving chronic homeless people experiencing a mental health crisis. The Community Connect receives referrals from a variety of outreach sources including Luke-Dorf’s PATH and Emergency Solutions Grant outreach, the Washington County Mental Health Court, and partner agencies serving homeless persons who meet the HUD definition of chronic homelessness.

Luke-Dorf is an active participant in the CoC known as the Housing and Supportive Services Network (HSSN), and supports efforts to increase resources and develop systems changes identified in the homeless plan, A Road Home and Opening Doors: Federal Strategic Plan to Prevention and End Homelessness.

The project addresses barriers specifically faced by communities of color and we work with property management to advocate. Cultural competency in recruitment and ongoing DEI training is provided to all staff. We are working with the Center for Equity and Inclusion to launch a committee devoted to DEI practices within the agency, monitoring our progress, addressing gaps, making recommendations.
