8 It appearing to the Board that the Tualatin Valley Highway Corridor Plan (TVCP) was
9 completed in 2013; and

10 It appearing to the Board that the TVCP is a focused and intensive examination of the
11 transportation system within the Tualatin Valley Highway Corridor; and

12 It appearing to the Board that the TVCP reflects a joint effort between the Oregon Department
13 of Transportation, Metro, TriMet, the City of Hillsboro, the City of Beaverton and Washington County;
14 and

15 It appearing to the Board that the TVCP seeks to help advance the aspirations, goals and
16 objectives of previously-adopted public policy and community planning efforts; and

17 It appearing to the Board that the TVCP seeks to provide a safer, more-complete and better-
18 connected network of streets, pedestrian, bicycle and transit facilities for the improved movement of
19 people, goods, and commerce into and throughout the project area, while improving livability and
20 sustainability within the Corridor; and

21 It appearing to the Board that TVCP identifies critical near term (within the next 15 years)
22 transportation improvement actions and encourages the application of an adaptive and shared
23 corridor management approach to prioritize and develop future transportation solutions for the
24 Tualatin Valley Highway Corridor; and

25 It appearing to the Board that the overarching goal of the TVCP is to reflect community needs
26 and desires for the corridor to evolve into a thriving, welcoming place that connects this vibrant
27 growing community now and for future generations; and
