GENERAL REQUIREMENTS												
<ol style="list-style-type: none"> 1. Applicant agrees to pick up litter or provide landscape maintenance at least twice a year for a minimum of two years. 2. Prior to working on a clean-up, the Applicant Representative shall have every adult participant sign a "Release of Liability – Adults" form and give it to Washington County. 3. Prior to working on a clean-up, for each participant between the ages of 12 and 17, the Applicant Representative shall obtain an "Authorization to Participate/Release of Liability – Minors" form signed by their parent or guardian, and give it to Washington County. (Children 11 and younger are not allowed to participate or be on site.) 4. Applicant shall ensure that each participant complies with and abides by all laws, rules, and regulations related to the safety and use of the roadway and such other terms and conditions as may be required by the Department. 5. Individual participants or applicants may be excluded from participation or the agreement revoked at the discretion of the Department for violations of any condition. 6. Final assignment of road section shall be at the discretion of the Department. 7. Applicant's objectives and values must be consistent with the public interest, the Department's charge and responsibilities under Oregon law or County ordinance, and consistent with Oregon law. 8. Applicant shall install County provided warning signs prior to any work and wear County-provided safety vests during work.

Note: County will review the application and, in its sole discretion, determine if the proposed location is an acceptable candidate for the Adopt-A-Road/Landscape program. Considerations in the County's review include sight distance, vehicle speeds, traffic volumes, shoulder width, and other safety considerations. County may revise the proposed limits or reject the road segment all together. Roads with significant segments of maintained or developed shoulders may not be good candidates for the Adopt-A-Road/Landscape Program.

The Department may furnish and erect two acknowledgment signs, one at each end of the adopted roadway section, with the group's name displayed, if desired. If the Department determines that the signs would create an unsafe condition or the segment being adopted is less than one mile, the Department may choose not to erect the signs.
