- The County Surveyor must approve all names **prior** to submittal of this petition.
- Street name suffixes (i.e. Court, Road, Lane) are assigned by the County Surveyor's Office.
- The fee for this action is at actual cost and this petition must be accompanied by a deposit of \$1,750 payable to the Washington County Surveyor's Office, \$280 of said deposit being nonrefundable. An additional charge may be necessary.
