

# WASHINGTON COUNTY OREGON

August 17, 2020 Update on Fall School Re-Opening 2020-21

Oregon Department of Education has put out guidance on the safe re-opening of K-12 private and public schools in Oregon. The first iteration of the guidance came out June 10<sup>th</sup> with the assumptions that:

- The majority of schools would be resuming as usual in the Fall
- They would release regularly scheduled versions on June 30, July 22, and August 11<sup>th</sup> with plans due for submission on August 17<sup>th</sup>
- Schools would be able to choose their instructional method: Comprehensive Distance Learning, Hybrid (online/in-person), or In-Person

# **New Metric Requirements**

Governor Kate Brown's recent press conference on July 28<sup>th</sup>, the requirement that schools are not able to reopen unless:

- County Metrics metrics to be met three weeks in a row:
  - Case rate: ≤10 cases per 100,000 population in the preceding 7 days\*
  - $\circ$  Test positivity: ≤5% in the preceding 7 days

- and –

- State Metric metric to be met three weeks in a row
  - Test positivity: ≤5% in the preceding 7 days

# Exceptions Washington County schools may be eligible for from August 11<sup>th</sup> Version of <u>Ready</u> <u>Schools, Safe Learners</u>:

Statewide:

- Provide In-Person Education for Kindergarten through 3<sup>rd</sup> Grade
- Limited In-Person Instruction for Specific Groups of Students
- School-wide in small districts (enrollment of less than or equal to 75 students) County Specific (WaCo eligible):

School-wide remote or rural schools in large

• School-wide remote or rural schools in larger population counties with a population of less than 30,000 and population density of less than 6 people per square mile

# Statewide

- Kindergarten through 3<sup>rd</sup> grade in-person instruction:
  - ≤30 cases per 100,000 over 7 days
  - Test positivity of 5% or less over 7 days
  - No COVID-19 cases for students/staff in the last 14 days
  - The test positivity in the county is less than or equal to 5% in the preceding 7 days for the past three weeks.
  - The case rate of the county is ≤30 cases per 100,000 in the preceding 7 days for the past three weeks.





This exception is due to younger students getting the virus at lowers rates, getting less sick when they do contract COVID-19, and spreading the virus less than older students and adults. Younger students also need more in-person instruction to build literacy and math skills that are critical for lifelong learning.

- Limited In-Person Instruction (In addition to Comprehensive Distance Learning):
  - o <u>Comprehensive Distance Learning Guidance</u> must be followed
    - No more than 10 students at a given time in cohort
    - Students cannot be part of more than two cohorts
    - Limited to two consecutive hours in school building and cannot be intermittent (single student/student group)
    - The absolute number of students who can be in a building with in a given week to 250
    - In-person can't take place of any CDL—cannot force students to be on campus
  - No student/staff cases in the last 14 days
  - Schools must fully comply with sections 1-3 of the <u>Ready Schools Safe Learners</u> <u>Guidance</u> via Oregon Department of Education.
- School-wide Small Districts
  - Enrollment total  $\leq$  75 students.
  - There is not community spread in the school catchment area or in the communities that serve as the primary employment and community centers.
  - The school is isolated by a significant distance from communities reporting COVID-19 community spread in the previous 3 weeks.
  - When a school/district is considering this exception, Public health should take into consideration the cases in the community, COVID-19 testing availability, in the community, recent percent positivity of tests, capacity in the community to respond to cases and outbreaks and the regional hospital capacity available for those with severe disease.

#### County-wide

- Large population counties with a population of less than 30,000 (defined rural or remote schools)
  - $\circ$  ≤30 cases per 100,000 over 7 days for the past three weeks.
  - $\circ$  Test positivity ≤ 5% over in the preceding 7 days for the past three weeks.
  - No COVID-19 cases for students/staff in the last 14 days
  - Test positivity in the county is less than or equal to 5% in the preceding 7 days for the past three weeks
  - School has enrollment of less than or equal to 250 and no more than 10% live outside of the school's catchment area
  - Must be 8 miles or more from any public school that serves any of the same grades
  - The school fully complies with sections 1-3 of the Ready Schools, safe Learners guidance and students cannot be part of any single cohort, or part of multiple cohorts that is less than 50 people

- Must be considered 'Rural' or 'Remote'
  - Remote is defined as a public or private school that is located more than 8 miles from any public school that serves any of the same grade levels. This is based on the definitions used in ORS 327.077.
  - Rural is defined using the National Center for Education Statistics "Locale" codes, these are available through ODE

#### Washington County School Re-Open Status by School District

At this point in time, Washington County is not able to reopen schools due to our rates being over this threshold. Schools are also currently contemplating doing Limited In-Person tutoring, learning support, etc. The plans for reopening the public schools districts on September 14 are as follows:

### School/District Fall Plans Due to ODE August 17

Regardless of the changes these new restrictions pose on re-opening of schools, public and private K-12 schools are still required to complete and share their Comprehensive Distance Learning plans and/or create a blueprint assessment for hybrid/in-person transition to be shared on their school/district site and also on <u>Oregon Department of Education's school page</u>. The school/district plans for Fall must be shared on their individual sites as well as sent into Oregon Department of Education by August 17<sup>th</sup>.

All plans geared towards hybrid or in-person learning must be turned into LPHA for assessment of sections 1-3 detailing Public Health Protocols; this does not include schools/districts who are doing Comprehensive Distance Learning and utilizing the statewide exception for limited in-person instruction.

All plans are to be submitted to Oregon Department of Education here.

#### **Higher Education**

Higher Education campuses in Washington County have until September 1<sup>st</sup> to submit their reopening plans to the Higher Education Coordinating Council. School starts September 28<sup>th</sup>. Most are leaning towards a distance learning model. The higher education facilities in Washington County are as follows:

- Portland Community College (Rock Creek Campus, Hillsboro Center, Willow Creek Center)
- Pacific University
- Pioneer Pacific College (Beaverton Campus)
- University of Portland (Westside Campus)

#### Childcare/Daycares

Oregon Department of Education Early Learning Division in partnership with Oregon Health Authority has released guidance on Health and Safety for Child Care and Early Education operation during COVID-19 (linked above). The guidance details the requirements for baseline, phase 1, and phase 2 counties including daily screenings, recordkeeping, personal protective equipment, group size and stability, cleaning and disinfecting, etc. This version of the guidelines takes effect on September 1, 2020. Any child care and early education provider may elect to implement earlier but must implement the guidelines in full if choosing to do so.

The guidelines are applicable to the following:

- All licensed program (certified and registered)
- All child care and preschool provided in public school settings
- All recorded programs, including school age

- Oregon Pre-kindergarten (prenatal to kindergarten), Preschool Promise, and Baby Promise
- Oregon relief Nurseries
- Early Intervention and Early Childhood Special education provided in child care or early education setting

The guidelines are intended to be helpful for individuals who provide family, friend and neighbor care but they are not required to be implanted in these settings.

# School Immunization Exclusion Reporting (K-12 private and public schools and certified daycares/PreKs/headstarts)

For schools:

- Schools that anticipate they will reopen (at least partially) later in the school year when it's possible, should plan on collecting immunization records, notifying parents of missing immunizations, and participating in immunization reporting and exclusion.
- Schools that are planning on exclusively online learning for the full school year will be able to count these students in the "not counted" category of the immunization report. They are still encouraged to collect immunization records, in preparation for inperson learning next school year.

For daycares:

- Daycares that are closed permanently will be considered 'inactive'
- Daycares that are closed temporarily, but at least through February 2021, can be temporarily exempt from immunization reporting for the year.
- Daycares that may reopen by January 2021, are required to report and collect immunization records, however may be exempt from reporting if they remain closed past January.

#### Washington County Support

Consistent with our regional local health partners, public health is a partner to support schools with guidance and promotion of public health principles, but schools and districts know their own resources and capabilities better than public health. The group agreed that schools and districts must take responsibility and ownership over their plans.

Washington County Public Health is aiding the public and private schools by providing tools and guidance to help them fulfill their blueprint requirements and plan for COVID prevention/outbreak.

- Disease mitigation and outbreak protocol documents and forms to assist in fulfilling blueprint requirements on public health protocol, screening, sanitation and disinfection, outbreak protocol, and disease prevention.
- Washington County has also acted as a bridge between Oregon Education Department, Oregon Health Authority, and the local schools via holding weekly school district administrator and nurse meetings in order to update schools on protocol and guidance changes along with answers to frequently asked questions.

## How Washington County is Decreasing COVID Rates

We are continuing to do contact tracing, work with employers, promote education about risk reduction/prevention, we also will be working with the 55 new Community-Based Organizations funded in our community to work on COVID outreach and education. Many of them also serve other areas and we are meeting to coordinate work with the state and other local public health.

Governor Brown discussed on her July 28<sup>th</sup> Press Conference on School Safety and Health that as a community, as a State, and as individuals we have a due diligence to take precautions and follow State protocols by wearing masks, washing hands, and staying home when sick.
