INCREASED OR IMPROVED PIT COUNT TRAINING: The PIT training for 122 enumerators (e.g. social workers, community leaders, formerly homeless/homeless) included the use of an APP (ArcGIS - Survey123) to map locations and collect the PIT interview data that is used for reporting and analysis. The APP automated the collection of data for the annual homeless census using cell phone devices with training provided on the APP use and privacy/security of all data collected. The data was imported into HMIS and used to extrapolate the 2020 Point-In-Time Census data.

CHANGE IN COC GEOGRAPHIC COVERAGE AREA: In October 2019, the CoC began implementing a national initiative to know all homeless persons in our community "by-name" under the Built For Zero model. To fully implement this model, the CoC convened an Outreach Committee focused on coordinating geographic coverage across the jurisdiction. The implementation includes provider agencies, law enforcement, day center staff, and community volunteers to identify and share information on homeless encampments and work collectively to engage and case conference the individuals living at these sites. This effort has resulted in greater knowledge of who is homeless and least likely to engage in coordinated entry or homeless services. The CoC is working off the by-name list created in HMIS to regularly make contact with these individuals.
