Sheltered population increased to 581 people in 2022, as compared to 359 people in 2021.

CHANGE IN EMERGENCY SHELTER CAPACITY: 496 emergency shelter beds operated as compared to 345 emergency shelter beds in 2021. This included 104 new year-round shelter beds leveraging a new Supportive Housing Services (SHS) local option levy and increased winter shelter beds providing a total of 275 seasonal beds.

CHANGE IN PARTICIPATION OF PROGRAMS DUE TO COVID-19: In response to the highly contagious Delta variant of COVID-19, facility-based shelters and transitional housing with common areas (e.g. shared restrooms, kitchen and living areas) reduced the number of occupants in the program. In addition, participants in the program were less likely to engage in shelter if they shared bedrooms given the risk of COVID transmission.

Unsheltered population decreased to 297 people in 2022, as compared to 357 people in 2021. CHANGE IN PARTICIPATION OF PROGRAMS SERVING GENERAL HOMELESS POPULATIONS (E.G. SINGLES & FAMILIES): In 2020 the CoC implemented a national Community Solutions initiative – Built For Zero – that included expanding outreach programs to provide geographic coverage and develop relationships with the unhoused population. In 2021, this initiative supported the transition of high-acuity chronicity unhoused people to transition from encampments to shelter and housing. The PIT unsheltered count included outreach and peer support staffing that performed Wellness Checks, provided information on COVID symptoms, testing and vaccination availability, and collected demographic data.

CHANGE IN RAPID RE-HOUSING CAPACITY: The COVID-19 CARES Act ESG-CV1/2 funded 144 beds of rapid rehousing providing new rent subsidy assistance that reduced the number of unsheltered people.

CHANGE IN OTHER SUPPORTIVE HOUSING SUBSIDY CAPACITY: The Housing Authority leased new Emergency Housing Vouchers (EHV) in alignment with the CoC coordinated entry with 58 beds occupied, and the local SHS levy added capacity with 470 beds leasing and 300 beds underdevelopment.
