Washington County Department of Housing Services, in partnership with public and nonprofit provider agencies, implemented a Homeless Management Information System (HMIS) in May 2006. This HMIS project will fund .4 FTE of the HMIS System Administrator position to oversee and support the HMIS, to include administration of user license agreements, technical assistance and training for HMIS users, HMIS manual development and implementation, publication of data quality and system performance reports, and local CoC HMIS Lead contact for HMIS software upgrades.

Many of the provider agencies serving Washington County homeless also have service centers located in Multnomah and Clackamas counties, comprising a Metropolitan Statistical Area (MSA). Washington and Clackamas counties entered into agreements with Multnomah County, the regional HMIS Lead agency, to use ServicePoint HMIS provided by WellSky. The use of ServicePoint allows for the formation of provider groups, which will facilitate the creation of reports for those agencies both at the agency and the MSA level.

The HMIS provides comprehensive data on service usage to analyze system performance in support of prioritizing funds, develop policy and programs to serve the demographics of current homeless populations, and report on implementation of the Emergency Solutions Grant and CoC Program performance outcomes.

HMIS is the tool utilized daily to communicate available bed resources in the CoC at "Community Connect" - a coordinated entry system - and referral to community-based housing and services. HMIS provides real-time data on homeless demographics accessing Community Connect, and is used annually to de-duplicate the CoC point-in-time (PIT) sheltered and unsheltered count. HMIS data is used to monitor system and program performance, bed utilization, and supports policy development in alignment with local and federal priorities.

The CoC submits the Longitudinal Systems Analysis (LSA), CAPER reporting, Annual Performance Reports (APR), the local Annual Homeless Report on Outcomes and Challenges, and other program and system-level data analysis using the HMIS.

The jurisdiction's Homeless Plan addresses the need to increase HMIS users as a strategy to achieving our vision of developing a comprehensive CoC system that prevents and ends homelessness.

An HMIS user group has been established as a subcommittee to the CoC. This group is comprised of HMIS users and leads from participating organizations and was formed to identify system wide training needs, serve as a platform for partners to engage with lead agency staff around data standards and data quality practices, and gather feedback and guidance on HMIS policies and procedures, data entry workflows, and other CoC HMIS related topics that arise across the implementation. Observations and recommendations from this group that rise to the level of policy change are forwarded to the CoC Board for review and approval.

The HMIS Lead Agency designated by the Continuum of Care and the HMIS vendor are jointly responsible for ensuring compliance with the technical standards. The CoC implements uniform technical requirements for HMIS and proper data collection and maintenance of the database to ensure the confidentiality of the information in the database. Data entry follows standards on participation, data collection, and reporting under the local ServicePoint HMIS and complies with 24 CFR part 578.57(a)(3). Security standards are directed to ensure the confidentiality, integrity, and availability of all HMIS information, protect against any reasonably anticipated threats or hazards to security, and ensure compliance by end users. Privacy training is a component of all new user training and is required for all users annually, supported by the launch of the HMIS Learning Management System (Power DMS) in September 2022. The most recent training was provided in January 2023 and included training on the new HMIS privacy protocols and updated privacy notice which were revised in alignment with HUD's recommendations and best practices.
