Update on KTS, grant applications- Rachael Mark

Applying for 2 different grants- Criminal Justice Community (CJC) and Office of Juvenile Justice and Delinquency Prevention (OJJDP)

CJC Grant Application:



Increase census= number of youth in the program.

Quality treatment for youth with co-occurring needs

Training for employees to keep up to date with best practices

OJJDP GRANT Application

Juvenile Budget – Lynne Schroeder

Budget was submitted as previously discussed. Lowering the number of detention beds from 17 to 14 starting July 1, 2021. All community contracts and staff have been able to remain.

BOC will be voting on the final budget in a couple of weeks and there are no surprises expected.

Anticipate more reductions within a year at the County level.

New Center for Juvenile Justice Reform technical assistance application. Transforming the Youth Justice System; Promoting equity, community, and well-being for youth of color – Lynne Schroeder

The group has done three other projects with Center for Juvenile Justice Reform Juvenile justice reform project (get actual name)
Evidence based data SPEP- for program evals (get actual name)
School Justice diversion pathways

Lynne discussed the program as

Weeklong program with 9 individual from 8 teams across the country. Teams will consist of individuals with lived experience- youth/family with previous experience in JJ. Line staff. Rep from justice system (judge). Law enforcement. 2 community representatives for those most impacted by the system. 1 or 2 from schools or mental health. There is an 18 month supportive process to move forward with technical support. One hour webinars are available. Get information from email. Questions/Comments?

Ximena Ospina-Todd – would be in favor of going forward with this due to her experience with other George Town sponsored programs.

Application due in August. Lynne has asked members to look over the project.

There is a lot of grant funds. Total cost will be \$20,000 which includes travel and stay for the 9 people in George Town.

Legislative Update – Lynne Schroeder

The 3 bills moving forward by the end of June 2021 are:

Creating automatic expunction for youth haven't been formalized in the Juvenile Justice system. The Juvenile department would need to take on the extra work of automatically processing the expunction. There is some contemplation by the legislature to provide funding for the staff to do this work. Goes into effect on Jan 2, 2022.

Amendment to Measure 110 allows for youth to be referred to the Juvenile Justice system to work with on an inform

The Third bill will eliminate Juvenile Department and Courts fines or fees as well as child support to Youth Authority when youth are out of the home.

Round Table- All

Rachael Schutz- Boys and girls clubs are opening our summer programing in person. In the Portland area there will be work on community violence prevention. They are going to hold a series of back-to-school youth and family vaccine clinics. Boys and girls club is still able to run the youth employment program for youth 16+. Naomi Hunsaker- working to spread the word about the current counterfeit pill issue and the resulting overdoses. Naomi shared the Tri-County press release and resources and they were forwarded to the JCPAC members.

Bria Woodworker-Schmid- The coping with conflict group just wrapped up last week with all participants completing. DRC is looking at a reopening plan with a possible hybrid model. DVRC program is hiring for 2 bilingual staff one clinical and one administrative the information was shared via email with JCPAC members.
