WELCOME

Larysa Thomas opened the meeting with a welcome and introductions to those attending and Alex Coleman followed with a review of the agenda.

APPROVAL OF MEETING MINUTES

The Council reviewed February meeting minutes. A question was raised about 3 and 5 % budget cuts for HHS, and clarification was added to the minutes. A question about Measure 110 funding was asked, and clarification was made that originally Washington County received 1.9 million over an 18-month contract ending December 2023. We have received the same budget for the next 18 months. Larysa made a motion to approve the February minutes with no changes, and Madhavi seconded the motion. David and Andrea abstained, none opposed, and members voted in favor. The motion was passed.

PRESENTATIONS

PUBLIC HEALTH 101: PUBLIC HEALTH SURVEILLANCE, *Alex Coleman*

Members watched a [short video](#) on Public Health Surveillance, providing an overview of what surveillance is, the different types of public health surveillance, and what makes a good surveillance system.

ORPHEUS DATA PRESENTATION, *Presented by Kathleen Rees, Epidemiology Supervisor and Catherine Desmarais, Epidemiologist; Research, Analytics, Informatics, and Data Program*

Kathleen Rees and Catherine Desmarais are Epidemiologists in public health's RAID program. They give an in-depth presentation on the kind of data we collect in Washington County Public Health. Public Health surveillance is defined as "The ongoing, systematic collection, analysis, and interpretation of health-related data essential to planning, implementation, and evaluation of public health practice, closely integrated with the timely dissemination of these data to those responsible for prevention and control" (slide 2).

ORPHEUS (Oregon Public Health Epidemiology User System) and DUDE (Directory of Useful Databases for Epidemiologists) are Washington County's surveillance systems. ORPHEUS holds data on many reportable infectious diseases.

In addition to the required notifiable data such as patient name, DOB, and diagnosis, Washington County collects REALD (race, ethnicity, language, and disability) and SOGI (sexual orientation, sex, and gender identity). The purpose of collecting this data is to understand inequities & address them. Data is deidentified and sent to the CDC. HIPAA does not apply to public health reporting. Communicable disease has always been a priority area for modernization.

ORPHEUS contains person level data, while DUDE contains outbreak level data and allows the tracking of outbreak trends.

QUESTIONS

Q: Does Tableau offer a historical perspective to compare what we're seeing now to historical data?

A: Some of that information is there. 5 year averages are common.

Q: can you talk about small numbers?

A: working to standardize language around small numbers or really small counts. Concern being that the data can become identifiable. Doing a lot of work with data equity to think about other ways to represent those numbers.

Q: if number is too small (less than 10) do they get rolled up into a different category?

A: Yes. We don't adjust small numbers.

Q: Are the public tableau dashboards downloadable?

A: It depends, some are.

Q: Do you ever link data to education systems, census data, other community datasets like those?

A: Not for communicable disease data.

Q: how secure is it, you hear about data breaches.

A: It's secure as the user, has two factor authentication. Not the same data as data sets that get leaked. More likely to have an email mistake than a data breach. It's not high value data to hackers.

Q: How recent is the data? TB dashboard shows through 2020.

A: we have access to all recent data, it's just a matter of getting it into a dashboard.

MEASURE 110 FOLLOW UP, *Chris Keating, Public Health Nursing Supervisor, Erin Parrish Senior Program Coordinator and Nancy Griffith, Addictions Program Coordinator*

Measure 110 funds go to Public Health as well as Behavioral Health. Nancy Griffith presented on the work Behavioral Health does with substance use disorder resources through Measure 110. Behavioral health resource networks (BHRN) were developed in every county in Oregon with Measure 110 funds. In Washington County we have 19 different agencies that make up our BHRN.

Services Included in the BHRN

-  Initial Screening for Substance Use Disorder services
-  Low Barrier SUD treatment
-  Peer Delivered services
-  Behavioral Health needs assessment
-  Supported Housing
-  Supported Employment
-  Harm Reduction

Impact of BHRN resources in Washington County

Chris Keating and Erin Parrish presented on the services public health provides through Measure 110. These funds have allowed us to expand into the field through Needle Exchange and the High-Risk Clinic. We do a lot of work with community partners in harm reduction such as the HIV Alliance. Needle exchange includes safe injection supplies, overdose prevention education, Naloxone distribution, and referrals for other treatments and services. There are Peer Recovery Specialists who provide case management and a warm hand-off to treatment. One of the goals of harm reduction services such as needle exchange is to build trust with those we are serving that when they are ready for treatment, they have built relationships with trusted providers. There are multiple funding sources for this work including federal grants and health share in addition to Measure 110.

Services Provided by Washington County Public Health (M110):

Communicable Disease at Needle Exchange

- Twice per week
- HIV Testing, prevention, and referrals at needle exchange
- Wound bandages and Wound kit distribution
- **Upcoming:** Hep C testing, Rapid HIV/Syphilis combo pilot

Communicable Disease at High-Risk Clinic

- One day per week
- Full STI screening (HIV, syphilis, chlamydia, gonorrhea)
- Treatment for positive STI clients and exposed partners
- MPox vaccinations
- Access to immediate addiction referral services



Request for Support

As Marie mentioned last night, the Public Health Division will be requesting that the Board approve an agreement to receive funding from HealthShare for 2024. We would like to you to review the policy statement below and let us know by [Friday, March 15](#) if you any concerns about the agreement, or questions you would like us to follow up on at our meeting in April. We will include time on the agenda for next month to follow up on this item.

Background

HealthShare of Oregon is a Coordinated Care Organization (CCO) that serves Oregon Health Plan (OHP) members in Clackamas, Multnomah, and Washington counties. They bring together health plans, providers, and community health resources so members can access the care they need to be well. In addition coordinating care and resources for members, HealthShare also works with community partners in health care, education, housing, transportation, and social services to broaden health access and opportunity. HealthShare provides funding to Washington County Public Health (WCPH) to sustain funding for community services. This funding supports program and service delivery which may include, implementation of the Community Health Improvement Plan (CHIP), prevention strategies (e.g., community, harm reduction, regional perinatal continuum of care), and direct care and case management services (e.g., tuberculosis).

Summary

WCPH has held an agreement with HealthShare since its inception in 2012. The most recent agreement with HealthShare expired on December 31, 2023. WCPH and HealthShare have reached an agreement for funding for 2024. The maximum amount of funding that can be received under this agreement is \$1,000,000.

Requested Board Action

Authorize the revenue agreement with HealthShare of Oregon for the term of January 1, 2024 through December 31, 2024.
