ADDITIONAL BACKGROUND INFORMATION:

Community Engagement Planning:

Washington County Public Health (WCPH) is responsible for developing a Modernization Implementation Plan (MIP) by 2025 that details how the Public Health Division will apply the foundational capabilities established under ORS 431.131 (Foundational capabilities) and implement the foundational programs established under ORS 431.141 (Foundational programs) as required by ORS 431.417 (Distribution of moneys to local public health authorities). As part of the development of the MIP, WCPH is required to make progress on the development of three plans, all of which need to be developed in collaboration with the community. The three plans are:

- 1. A local or regional all-hazards preparedness plan
- 2. A local or regional climate adaptation plan
- 3. A local or regional health equity action plan

Additionally, these plans will need to align with WCPH's Community Health Improvement Plan (CHIP). All four of these plans must engage community in understanding needs and identifying priorities and strategies to reduce inequities.

This work will be implemented in four phases, with each phase approximately 4-6 months. The later phases will build on the planning and engagement activities in Phase 1 and Phase 2. We hope to contract with the same consultant as phases 3 and 4 are developed.

WCPH will be releasing a request for proposals (RFP) in the next several weeks seeking a contractor to help support the first two phases of the planning and engagement process. The first two phases will consist of working with the consultant to develop a community engagement plan that considers the needs of the three modernization plans and the CHIP, and information that has already been collected; and implementation of the first part of the developed community engagement plan, and analysis of the data collected.

The PHAC is being asked to provide feedback on the overall concept being proposed within the RFP, and provide input on any additional considerations related to the community engagement process.

Legislative Update:

Last month the Council received an update on the 2023 Oregon Legislative Session, focusing on some of the priority bills related to Health and Human Services. This month, the group will receive an update on where various bills are at currently, as well as updates related to the governor's budget and Public Health Modernization.

The Council did vote last month to support proposed public health legislation and the Modernization budget. Depending on where things are in the legislative process, the group may be asked to submit testimony to the legislature.

Budget Update:

Last month the Council received an update on one of the strategies being proposed to reduce general fund subsidy within the Public Health Division by moving towards a cost recovery model for environmental health fees. This month the focus of the conversation will be on the overall budget process the County is engaged in, and recommendations for future budget cycles.

The PHAC is being asked to vote to put forward recommendations to the Board of Commissioners related to the budget process.
