# Regional Public Health Ethics Deliberations

### **Background and Context**

 Regional Public Health Leadership Group (RPHLG) expressed support to review and consider a proposal for coordinating, aligning, and/or collecting work towards cross jurisdictional approaches for conducting public health ethics committee reviews and deliberations

- Public health ethical deliberations are a tool for transparent decisionmaking resulting in better decision making
- Public health ethics committees are responsible for reviewing and deliberating on community-based public health issues and developing strategies, recommendations, and/or considerations that guide LPHA decision-making with input from a diverse group of community volunteers
  - In Washington County, the PHAC serves as the Public Health Core Ethics Body
- As an accredited public health division, we are required to have a defined process for documenting the consideration, deliberation, and resolution of ethical issues
- Each LPHA in the region approaches its public health ethics committee in different ways and we're exploring how to better coordinate and standardize across the metro region

### **Proposed Options**

- Quad County Regional Public Health Ethics Committee
  - Full regionalization through creation of a standalone regional public health ethics committee
- Regional Public Health Ethics Community of Practice
  - Regular meetings with LPHA staff responsible for planning and conducting local ethics deliberations to share and/or jointly plan together for local deliberations
- Maintain Status Quo
  - Each LPHA continues to operate independently

# Public Health Modernization: Process Metrics

### **Background and Context**

- The state is required to use accountability metrics to "encourage the effective and equitable provision of public health services" (ORS 431.115)
- The state's Public Health Advisory Board (PHAB)
  has established a framework adopted the

## Development of Health Outcome Indicators

- Conference of Local Health Officials (CLHO) put together work groups with representation from LPHAs across the state
  - Focus on communicable disease and environmental health
- PHAB reviewed the recommendations from the work groups and voted to approve the health indicators in 2023

### Health Outcome Indicators

- Reduce the spread of syphilis and prevent congenital syphilis
- Protect people from preventable disease by increasing vaccination rates
- Build community resilience for climate impacts on health: extreme heat, wildfire smoke, and drinking water

### Syphilis

- Rate of congenital syphilis
- Rate of syphilis (all stages) among people who can become pregnant
- Rate of primary and secondary syphilis

### Vaccination Rates

- Two-year old vaccination rate
- Adult influenza vaccination rate, age 65+

### Climate Impacts on Health

- Emergency department and urgent care visits due to heat
- Hospitalizations due to heat
- Heat deaths
- Respiratory (non-infectious) emergency department and urgent care visits
- Community water system health-based violations
- Mental health effects of climate change

### Washington County Framework

- Division wide approach for how we address these areas
- How we work with partners to address these issues
- Balance between highlighting what we're already doing (and doing well) and where there are opportunities for growth and equity goals
